Sangeeta Devi D/O: Sabitri Keot of Huplong T.E married to Shri: Rajesh Kumar of South West Delhi, after the marriage she was frequently tortured and abused by her husband but she failed to escape due to financial inability.</p> <p>Last year 2017 somehow she managed to convince her husband and came to Huplong T.E with her one minor child (Son) to meet her mother and decided to not to go back in her mother-in-laws house, later on she came to know that her husband Rajesh Kumar was involved in a case under POCSO Act and he is under police custody.</p> <p>Here in Huplong T.E, Tripura she engaged in day labour work and maintaining her daily needs. On February 2018 her husband was released on Bail by court, he contact with her by phone and asked her to go back to Delhi but she denied to going back, as on 1st May 2018 he reached Huplong T.E (Tripura) and convince her relatives and forcing her to go back with him also the good numbers of local people of Huplong T.E allegedly compelled her to go with her husband, and threaten her.</p> <p>Around 8AM I have reached the destination along with one women PLV, Rinku Nath and tried to talk with the local people but we failed to convince the locals and I called Dharmanagar Women Police they reached the place in no time and discussed with the local people but nothing works, later on with the help of the police we rescued the victim Smt: Sangeeta Devi and her minor child (Son).</p> <p>The said matter was reported to the Chairman, Sub-Divisional Legal Service Committee, Dharmanagar and Smt: Sangeeta Devi and her minor Child namely Laksh Sharma was provided proper protection and shelter with the help of D.I.S.E, North Tripura. Around 11.30 AM I have reached the destination and with the help of the local people I rescued the victim Smt: Laxmi Debi Tewari and her minor sister. The said matter was reported to the Chairman, Sub-Divisional Legal Service Committee, Dharmanagar and Smt: Laxmi Debi Tewari and her minor sister namely Namita Tewari was provided proper protection and shelter with the help of D.I.S.E, North Tripura. She was abducted to Kumarghat and she was badly tortured, physically assaulted and raped by the main accused Imran Hussain and in the same day evening thrown her at Pechartal Police Station area, locals rescued her and admitted to Pechartal Hospital and inform the Pechartal Police, later on, Pechartal Police contacted with her family and then she was shifted to Dharmanagar District Hospital. Next day 20th May 2018 on the morning the victim family approached Dharmanagar Women PS and orally reported the incident to Women PS, but police didn't act accordingly.</p> <p>Around 9 AM I reached Dharmanagar District Hospital and talk to the victim family, FIR written and submitted to Dharmanagar Women PS and requested to do the Medical examination as early as possible and but police has no intention to act accordingly. Next day I have met with Sub-Divisional Police Officer, Dharmanagar and discussed the case related matter, later on 23.05.2018 Dharmanagar Women PS did the Medical Examination of the victim.</p>	63/DR/17/213/21.05.2018
